


MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on 27th day of November, 2017 between **MENTOR ACADEMY**, Dimapur in collaboration with **ALL INDIA YUVA COMPUTER SAKSHARATA MISSION** and **PUBLIC COLLEGE OF COMMERCE**, Dimapur to initiate mutual relation in academic co-operation. The Mentor Academy and Public College of Commerce agree to establish the Academic Programme for students in the area of Personality Development and Spoken English Training and in accordance with terms and conditions set forth in this Memorandum of Understanding.

1. That, the objective of this Memorandum of Understanding is to provide training on Personality Development and Spoken English Programme to the students of B.Com 6th Semester.
2. That, the Mentor Academy shall engage weekly 03 classes of 45 minutes duration for the students of B.Com 6th semester on different modules of Personality Development during 27th November, 2017 to 31st March, 2018.
3. That, the College shall collect ₹600/- (rupees six hundred) per student for the programme, out of which ₹500/- (rupees five hundred) per student shall be paid to the Mentor Academy and ₹100/- (rupees one hundred) shall be treated as registration fee which shall be kept by the College. The total amount payable to the Mentor Academy shall be based on the actual number of students from whom the fees is realized.
4. That, the College shall pay the training fee to the Mentor Academy in two installments, i.e. 1st installment on or before 15th December, 2017 and 2nd and final installment on the day of certificate distribution to the students (5th week of March, 2018).
5. That, by the end of the programme, an Appraisal Test shall be conducted, based on which the Performance Certificate will be issued by the Mentor Academy to the students who have participated in the programme and from whom the fees have been realized.
6. That, the College shall make the payment by cheque in favour of Ms. Moanaro Longkumer,
• Managing Director of Mentor Academy.
7. This Memorandum of Understanding is executed in duplicate with each copy being the official version and having equal legal validity.

8. By signing below, the management of both the organizations, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as on the date and year mentioned above.
