Objectives of PC Parent-Teacher Association (PCPTA)

The objectives of the PCPTA will be as follows:

- ▶ To represent the views of parents and to promote a positive view of the parents through liaison with the parents representatives on the association.
- ▶ To establish a forum through which parents can communicate their opinion and concerns regarding the college, to identify issues and possibly work towards a solution.
- ▶ To establish a forum through which parents and teachers can exchange information and research in relation to education/ welfare of children.
- ▶ To support parents, teachers and students to ensure that all students are treated with or in accordance with the ethos of the college.
- ▶ To help raise funds for PCPTA in consultation with the principal for student's welfare.
- ▶ To keep parents informed about activities planned for the college.

What is NOT the role of the PCPTA

- To get involved in individual complaints.
- Day to day running of the college.
- Curriculum.
- Appointments of teachers.
- Carrying out activities without consultation with the Principal or Governing Body.
- Portraying the college staff, the management and pupils in a negative manner.

Constitution

Article-I

Name and definition:

The Name of the association shall be **Public College Parent Teacher Association**. Hereinafter referred to as "**PCPTA**"

Article-II

Objectives:

As defined in the **objectives** of PCPTA.

Article-III

Non-profit, non-political & non-partisan character.

PCPTA shall:

- a) Be exclusively educational in character as described in article-II.
- b) Not to be operated for profit.
- c) In its aims and activities be politically neutral.

Article-IV

Eligibility

- a) Parents and legal guardian of the students presently enrolled at Public College are automatically members of PCPTA.

Article-V

Association and Members, Tenure:

- The PCPTA shall be administered by a convener, three (3) Faculty members duly appointed by the Principal.
- Three (3) Parents Representatives to be nominated by the convener.
- Tenure of the convener and faculty members depends on the Principal as and when there is a need for re-constitution of members.
- The tenure of Parents Representatives shall continue till their children/ward are in regular- enrollment of the college
